COLLEGE CREDIT REGISTRATION FORM

The Gap Year Association (GYA) administers a college credit program with the University of Montana (UM) serving as its School of Record. This relationship allows students enrolled in participating GYA-Accredited Programs to receive college credit for additional independent coursework completed during their gap year program.

PROCEDURES:

- Students enrolled in a participating GYA Accredited Program are eligible to receive college credits from the University of Montana (UM).
- Students should notify Where There Be Dragons of their desire to earn college credit prior to their program start. The deadline to enroll in college credit is two weeks prior to the program start date. Late registrations will be granted on a case-by-case basis (depending on the length of the program) and will incur a \$100 late registration fee by GYA.
- To enroll in the college credit option, complete the second page of this form and return to Where There Be Dragons.
- Where There Be Dragons will invoice students directly for participation in the college credit option. Federal
 financial aid is not available; however, third party payments such as AmeriCorps Education Awards and 529 funds
 may be used. GYA and UM will work individually with students wishing to use these payment options. Please notify
 Where There Be Dragons as soon as possible if you wish to utilize a third party payment method.
- GYA will register students with UM and introduce students to their GYA Instructor of Record.
- Coursework is due to Instructors of Record no later than 30 days after the program end date. Instructors of Record will submit grade reports to GYA within 30 days of receiving completed coursework.
- GYA will submit credit registration forms and grade reports to UM on the last business day of each month. Grades will be available by the 15th day of the following month. Students who do not complete their GYA Accredited Program will be withdrawn from the college credit, incurring a "W" on their official UM transcripts. Incomplete or missing coursework will result in an assessment of an "I" (Incomplete) on their official UM transcripts.
- Once grades are posted, UM will email students a registration confirmation with their UM Student ID number and
 instructions to order official transcripts. Students must pay a small additional fee for any official transcripts
 ordered.
- Students will NOT receive a tuition statement tax form (Form 1098-T) for receiving college credit. In lieu of a Form 1098-T, it is recommended that you maintain proof of tuition payment to Where There Be Dragons and documentation of enrollment with the University of Montana in the form of a student ID number and/or official transcripts.
- UM will make the final determination on matters in question.

TRANSCRIPT DETAILS:

On your UM college transcript, course credits are listed in the corresponding semester you studied at Where There Be Dragons.

Traditional letter grades are assigned by the University of Montana based on the corresponding course grades on your GYA course report. UM uses a standard 4.0 grading scale (A=4.0, A-=3.7, B+=3.3, B=3.0, B-=2.7, C+=2.3, C= 2.0, and C=1.7).

A student's degree-granting institution determines if and how credits will transfer. If you have been accepted to OR are currently enrolled in a degree-seeking program, we strongly recommend asking your advisor or admissions office how these credits will apply to your degree program BEFORE submitting this form to Where There Be Dragons.

COURSE EQUIVALENCIES:

Select your course options, noting that you may receive 3 semester credits for a total of 45 contact hours per course. Each course requires additional coursework outside of the daily activities of your program. Course syllabi are available from both Where There Be Dragons and GYA. Please review the expectations for each course in detail before enrolling.

Submitting Your Registration Form & Payment

- 1. **SUBMIT YOUR FORM:** Return your form via email to <u>studyabroad@wheretherebedragons.com</u> by the deadline (see website).
 - a. Please ONLY return your form to Dragons, not to GYA or UM.
 - b. Registration is managed by Dragons and you do not need to apply directly to UM.
- 2. **SUBMIT PAYMENT:** After you register, a fee will be added to your MyDragons account. Please pay this promptly. These fees are in addition to the Dragons land-cost price and are all payable to Where There Be Dragons. The fee to take up to 4 courses (12 semester credits) through the University of Montana is \$2,000
